How confident are you in the identification (as a %) and why?	100%. Photos clearly show diagnostic black underwing coverts, slightly upturned bill, uniform greyish-brown upperparts and short, somewhat (although not very pronounced) bulging cream supercilium.		
Did you find and/or identify the bird initially? Who else recorded the bird and do they agree with the identification?	As far as we are aware, we discovered the bird. Initially, on 17/3 it was not seen in flight and was photographed as a Black-tailed Godwit, a species that had been reported on the island 1-2 weeks earlier. On review of the photos, it became clear the bird almost certainly was a Hudsonian Godwit due to its slight but clearly upturned bill. The bird was next encountered on 20/3 when it was seen and photographed in flight, showing its diagnostic underwing pattern. The bird was seen, photographed and reported on eBird and FB by a number of other birders, including Ian Hutton, Dick Jenkin, Jim Smith, Sue Lee and Richard Arnold.		

What experience have you had with this species?	None but extensive experience with Bar-tailed and Black-tailed Godwit.
Has this species been seen at this location before? When?	No previous records from Lord Howe Island, according to Ian Hutton and BARC.
