Date(s) and time(s) of record (First and last date of occurrence if known)	20/06/2021 11:09 viewed and photographed by both Michael Kearns (MK) and Jon Spicer-Bell (JSB). The bird had been seen earlier that day by MK at the same location.
	At time of writing the bird hasn't been seen since.
How many individuals were there?	1
What was the distance to the bird(s)?	Initially ~40m, then as close as ~5m
Habitat description	Urban lawns, on a raised hill overlooking an oceanic beach and rockpools.
Sighting conditions (e.g. weather, visibility, light conditions)	Weather was heavily overcast with occasional periods of rain and otherwise persistent showers. Strong southerly winds. Apart from occasional rain visibility was clear, no obstructing vegetation or other obstacles.
	Equipment –10x42 binoculars and a DSLR camera with 100-400mm lens was used.
How confident are you in the identification (as a %) and why?	100% due to the clear views and reasonable photographs obtained of the bird showing its field characteristics.
Did you find and/or identify the bird initially? Who else recorded the bird and do they agree with the identification?	I arrived at Fort Scratchley Function Centre balcony at 10:42 for sea- watching. Coincidently MK was already onsite. MK advised JSB that an Arctic-type Tern had been seen earlier. At 11:09 MK called out that the Arctic-type Tern had reappeared. Both MK and JSB started viewing/photographing and pursued the bird into the lawns of Fort Scratchley where prolonged close views and photographs were obtained.

	At the time identification was tentatively an Arctic Tern, however upon closer examination and review of the observations and photographs, bird guides and collaboration with Facebook birding groups identification of Black-fronted Tern was 100% agreed upon.

Plumage	Black cap extending to bill with white line separating cap from surrounding grey plumage. White rump. Otherwise all grey. Tail forked.	
Bare parts	Bill bright orange with a faint black tip.	
Moult details	Breeding plumage.	
Structure and 'jizz'	Buoyant, agile flight in strong wind. Silver Gulls were nearby, and this bird was notably smaller approximately ~50% the size of the Silver Gulls.	
Calls	No calls were noted.	
Behaviours	Flying low over the lawns of the Fort, foraging close to the grass. Generally moving south in lines above the lawn before flying up and back to the northern end and starting again. Almost landed occasionally and at least once took a worm. Last views the bird headed out to sea, last seen above the breaking waves over the rock platforms.	
Age, sex and/or taxonomy	Unknown

Combination of diagnostic features (Bright orange bill; black cap extending to bill; white line separating cap; white rump; otherwise all grey plumage) observed eliminate all other Terns.
